From data-driven policy-making to the stewardship of public records, how local and state officials manage the public's "big data" will be the focus of "Governing in a Digital Age," a two-panel event on Thursday, February 25, at 3 p.m. at the Rappaport Center for Law and Public Policy at Boston College Law School.
